(Elliott International), and Elliott International Capital Advisors Inc. (International Advisors and collectively with Elliott Associates and Elliott International, the Reporting Persons). Paul E. Singer (Singer), Elliott Capital Advisors, L.P., a Delaware limited partnership (Capital Advisors), which is controlled by Singer, and Elliott Special GP, LLC, a Delaware limited liability company (Special GP), which is controlled by Singer, are the general partners of Elliott. Hambleton, Inc. (Hambleton) is the general partner of Elliott International. International Advisors is the investment manager for Elliott International. International Advisors expressly disclaims equitable ownership of and pecuniary interest in any Common Stock.

Elliott Associates, Elliott International and International Advisors aggregate beneficial ownership of 1,786,500 shares of Common Stock constitutes 8.3% of all the outstanding shares of Common Stock.
