- (1) On February 26, 2019, 7,727 restricted shares of Mr. Ware's Company stock, granted February 26, 2016, vested. On February 26, 2019, Mr. Ware automatically surrendered 3,369 of the 7,727 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 26th vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
