Item 1.01. Entry into a Material Definitive Agreement.

Line of Credit. On August 20, 2010, the Company executed an agreement to renew its existing unsecured revolving credit facility between the Company and its subsidiaries and Regions Bank. The amount of the revolving credit facility is \$30,000,000 and is effective August 26, 2010 through August 25, 2011 with an interest rate at the higher of prime rate, the federal funds rate plus 1/2 of 1% or LIBOR. The credit agreement is attached hereto as Exhibit 10.1 and is incorporated herein by this reference.

Item 2.02. Results of Operations and Financial Condition.

The Company released its results of operations for the thirteen-week and twenty-six-week period ended July 31, 2010, in a press release issued on August 20, 2010.
