- (2) Shares held in The Malquist Family Trust, dated February 5, 1999, with Malyn K. Malquist and Georgia G. Malquist, Trustees
- (3) No conversion price. Shares awarded if performance measure is met.
- (4) Each performance cycle is three years in length. Shares will be issued at the end of each three-year cycle if performance measure is met.
