(1) Includes 2,806 shares acquired through the reinvestment of dividends on January 3, 2005, at a price of \$63.0295 per share.

The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a January 4, 2005 stock fund price of \$61.78 per share.

(4) The phantom stock units were accrued under the Johnson Controls Long-Term Performance Plan and are to be settled 100% in cash upon the reporting person's retirement.
