- (2) This option was previously reported as an option for 72,935 shares of common stock at an exercise price of \$32.62 per share, but was adjusted to reflect WCI's 3-for-2 stock splits in the form of 50% stock dividends effective June 24, 2004, and March 13, 2007. Accordingly, on March 13, 2007, the date the stock dividend was paid, the option became exercisable for 164,105 shares at an exercise price of \$14.50 per share.

- (3) This option was originally reported as an option for 72,327 shares of common stock at an exercise price of \$37.40 per share, but was adjusted to reflect WCI's 3-for-2 stock splits in the form of 50% stock dividends effective June 24, 2004, and March 13, 2007. Accordingly, on March 13, 2007, the option became exercisable for 162,737 shares at an exercise price of \$16.62 per share.
