The new grant is for 3,324 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 1,096 units on 2/22/11, on 1,097 units on 2/22/12 and on 1,131 units on 2/22/13, subject to continued employment by the Reporting Person on the vesting dates.

The new grant is for 13,296 shares of common stock represented by performance-based restricted stock units, which may be adjusted up or down at the time the performance restriction lapses. The restriction may lapse with respect to 33% of such shares on each of 2/22/11 and 2/22/12 and with respect to 34% of such shares on 2/22/13 contingent on meeting a cash earnings per share growth hurdle for 2010 and subject to continued employment by the Reporting Person on the vesting dates.

The total number of securities beneficially owned includes: (a) 4,896 unvested time-based restricted stock units granted 12/21/09; (b) the new grant for 3,324 time-based restricted stock units; and (c) the new grant for 13,296 performance-based restricted stock units.
