MTS Announces Subscriber Growth Numbers for December 2005

Moscow, Russian Federation January 17, 2006 Mobile TeleSystems OJSC (MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached **58.19 million users on December 31, 2005**.

During December 2005, MTS consolidated subscriber base increased by 4.08 million subscribers, of which 2.61 million were added in Russia.
