### **PART III NARRATIVE**

State below in reasonable detail why Forms 10-K, 20-F, 11-K, 10-Q, 10-D, N-SAR, N-CSR, or the transition report or portion thereof, could not be filed within the prescribed time period.

On July 25, 2006, the Company reported two recent material acquisitions of oil and gas assets. The acquisition of certain assets of Blacksand Energy, LLC, at a contract price of \$291 million, was completed on August 1, 2006 and the acquisition of certain assets of Kaiser-Francis Oil Company, at a contract price of \$125 million, closed on August 14, 2006. Both acquisitions were financed with borrowings under the Company's new revolving credit facility and bridge loan which were entered into by the Company on August 1, 2006. Due to the material nature of these acquisitions and the resulting significant increase in the Company's outstanding indebtedness, additional time was needed to analyze the accounting and disclosure necessary in the Form 10-Q relating to the acquisitions, the new debt financing arrangements and the changes to the Company's business.

Additionally, subsequent to June 30, 2006, the Company hired experienced personnel in several senior positions within the Company's accounting department as part of its continuing remediation activities of the Company's internal control over financial reporting. All of these personnel changes occurred within 30 days of the due date of the Company's Form 10-Q, which extended the normal accounting closing process.
