(1) The reporting person was granted 5,500 restricted stock units on July 31, 2008, of which 3,300 vested immediately. The transaction reported herein represents the vesting of one-half of the 2,200 restricted stock units that did not vest immediately. The balance of the award vests on July 31, 2010. Each unit converts into a share of common stock on a one-for-one basis.

(2) The transaction reported herein represents the vesting of one-fifth of 10,000 restricted stock units granted on July 31, 2008. The balance of the award will vest in four equal installments on each of July 31, 2010, 2011, 2012 and 2013. Each unit converts into a share of common stock on a one-for-one basis.
