Portugal Telecom, SGPS S.A. ( PT ) informs that it was notified by Barclays Plc of a sale, on 2 November 2011, of 2,955,000 PT shares and a purchase, on the same date, of a forward contract equal to 2,955,000 PT shares, both by Barclays Capital Securities Ltd. Nonetheless, Barclays Plc's long position in PT remained above the 2% threshold of reportable interests as was previously disclosed.

It was further communicated that Barclays Capital Securities Ltd currently holds the following financial instruments:
