In addition, pursuant to Rule 416(a) under the Securities Act of 1933, as amended (the Securities Act of 1933) this Registration Statement also covers such additional shares of Common Stock as may be issued pursuant to the provisions of the Plan to which this Registration Statement relates.

(2) Pursuant to Rules 457(c) and 457(h)(1) under the Securities Act of 1933, the proposed maximum offering price per share and the maximum aggregate offering price for the shares have been calculated solely for the purpose of computing the registration fee on the basis of the average high and low prices of the Common Stock as reported by the Nasdaq Global Select Market on June 13, 2013 to be \$11.95 and \$12.25, respectively.



**EXPLANATORY NOTE**
