In connection with the restatement of certain of our financial statements, as previously disclosed in our Current Report on Form 8-K filed with the Securities and Exchange Commission on November 27, 2013, the lenders under each of our \$25.0 million secured revolving credit facility and our \$150.0 million secured revolving credit facility have waived, until February 28, 2014, any default resulting from our not timely delivering our financial statements for the quarter ended September 30, 2013.
