**Presentation to Include New IMMU-132 Data and Latest Data on Other Programs**

**Morris Plains, NJ, January 5, 2017** **Immunomedics, Inc. (NASDAQ: IMMU)** today announced that it will hold an Investor R&D Day to present new and updated data for IMMU-132 and the latest data on the Company's other clinical and preclinical programs. The R&D Day will be held at The Roosevelt Hotel in New York City on January 18, 2017 from 9 a.m. to 1 p.m. Eastern Time.

Cynthia L. Sullivan, President and Chief Executive Officer, said, "We are pleased to announce Immunomedics' Investor R&D Day, which will include the participation of several highly respected physicians who are serving as independent scientific advisors to our ongoing clinical studies related to IMMU-132. We look forward to presenting encouraging new data for IMMU-132 at this critical point in our growth trajectory, as well as highlighting the additional value creation inflection points as a result of our robust pipeline."

The R&D Day will be hosted by members of the Immunomedics executive leadership team and will feature independent scientific advisors participating in the Company's ongoing clinical studies related to IMMU-132, including the following participants:

**About Immunomedics**

Immunomedics is a clinical-stage biopharmaceutical company developing monoclonal antibody-based products for the targeted treatment of cancer, autoimmune disorders and other serious diseases. Immunomedics' advanced proprietary technologies allow the Company to create humanized antibodies that can be used either alone in unlabeled or "naked" form, or conjugated with radioactive isotopes, chemotherapeutics, cytokines or toxins. Using these technologies, Immunomedics has built a pipeline of eight clinical-stage product candidates. Immunomedics' portfolio of investigational products includes antibody-drug conjugates (ADCs) that are designed to deliver a specific payload of a chemotherapeutic directly to the tumor while reducing overall toxic effects that are usually found with conventional administration of these chemotherapeutic agents. Immunomedics' most advanced ADCs are sacituzumab govitecan (IMMU-132) and labetuzumab govitecan (IMMU-130), which are in Phase 2 trials for a number of solid tumors and metastatic colorectal cancer, respectively. IMMU-132 has received Breakthrough Therapy Designation from the FDA for the treatment of patients with triple-negative breast cancer who have failed at least two prior therapies for metastatic disease. Immunomedics has a research collaboration with Bayer to study epratuzumab as a thorium-227-labeled antibody. Immunomedics has other ongoing collaborations in oncology with independent cancer study

groups. The IntreALL Inter-European study group is conducting a large, randomized Phase 3 trial combining epratuzumab with chemotherapy in children with relapsed acute lymphoblastic leukemia at clinical sites in Australia, Europe, and Israel. Immunomedics also has a number of other product candidates that target solid tumors and hematologic malignancies, as well as other diseases, in various stages of clinical and preclinical development. These include combination therapies involving its antibody-drug conjugates, bispecific antibodies targeting cancers and infectious diseases as T-cell redirecting immunotherapies, as well as bispecific antibodies for next-generation cancer and autoimmune disease therapies, created using its patented DOCK-AND-LOCK® protein conjugation technology. The Company believes that its portfolio of intellectual property, which includes approximately 304 active patents in the United States and more than 400 foreign patents, protects its product candidates and technologies.
