The 4,000 restricted stock units vest 50% of the total units on April 30, 2013, 25% of the total units on April 30, 2014 and 25% of the total units on April 30, 2015, subject to continued service as a director or consultant. Vested shares will be delivered to the reporting person as soon as practicable following a vesting date.

(1) Includes 1,000 restricted stock units granted on June 1, 2010 which fully vest on June 1, 2013 and 2,000 restricted stock units granted on May 12, 2011 which vest 50% of the total units on April 30, 2013 and 50% of the total units on April 30, 2014, subject to continued service as a director or consultant. Vested shares will be delivered to the reporting person as soon as practicable following a vesting date.

(3) This option is subject to a three-year vesting period with 50% of the total award vesting on April 30, 2013, 25% of the total award vesting on April 30, 2014 and 25% of the total award vesting on April 30, 2015, subject to continued service as a director or consultant.
