Market leveraged stock units vest 25% over one-, two-, three- and four-year performance periods using a conversion formula under which
- (4) the number of shares earned is adjusted at each vesting date based on the percentage change in the Company's stock price plus dividend equivalents accrued during the vesting period. Each marked leveraged stock unit represents a contingent right to receive one share of Avery Dennison Corporation common stock, plus dividend equivalents.
