As previously disclosed, on January 14, 2009, Gottschalks Inc. (the "Company") filed a voluntary petition (the "Chapter 11 Petition") for relief under Chapter 11 of the United States Bankruptcy Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") (administered under Case No. 09-10157). The Company will continue to manage its properties and operate its business as a "debtor-in-possession" under the jurisdiction of the Bankruptcy Court and in accordance with the applicable provisions of the Bankruptcy Code.

On March 25, 2009, the Company filed with the Bankruptcy Court its monthly operating report for the period January 14, 2009 to January 31, 2009 (the "January Monthly Operating Report"). The Company also filed with the Bankruptcy Court on March 25, 2009 its monthly operating report for the month ended February 28, 2009 (the "February Monthly Operating Report").

The January and February Monthly Operating Reports are attached hereto as Exhibits 99.1 and 99.2, respectively, and are incorporated herein in by reference. This current report (including the exhibits hereto) will not be deemed an admission as to the materiality of any information required to be disclosed solely by Regulation FD.
