(1) 18,750 shares of previously acquired Eastern Company stock were surrendered to Eastern Treasury at the closing price on June 14, 2010 of \$14.25 per share, for the purchase of stock options by Mr. Sullivan.

(2) 30,000 shares were exercised on June 15, 2010 at \$9.50 per share by Mr. Sullivan. The original 7/19/2000 option was for 20,000 shares at \$14.25 per share. 4,810 shares were vested on 1/1/2001; 7,017 shares were vested on 1/1/2002; 7,017 shares were vested on 1/1/2003 and the remaining 1,156 shares were vested on 1/1/2004. As a result of a 3-for-2 stock split effective 10/18/2006, this option is now 30,000 shares at \$9.50 per share.

(3) The original 7/19/2000 option was for 20,000 shares at \$14.25 per share. 4,810 shares were vested on 1/1/2001; 7,017 shares were vested on 1/1/2002; 7,017 shares were vested on 1/1/2003 and the remaining 1,156 shares were vested on 1/1/2004. As a result of a 3-for-2 stock split effective 10/18/2006, this option is now 30,000 shares at \$9.50 per share. On June 15, 2010 30,000 shares were exercised at \$9.50

per share, leaving a zero balance.

The original 4/26/2001 option was for 15,000 shares at \$14.40 per share. 5,800 shares were vested on 1/1/2004; 6,944 shares were vested (4) on 1/1/2005; and the remaining 2,256 shares were vested on 1/1/2006. As a result of a 3-for-2 stock split effective 10/18/2006 this option is now for 22,500 shares at \$9.60 per share.
