  - (2) 838 Restricted Stock Units (Common Stock equivalents) were granted pursuant to the WD-40 Company 2007 Stock Incentive Plan. The Market Share Units (MSUs) will be settled solely with Issuer Common Stock upon performance vesting as provided for in the Award Agreement for the MSUs following a 3-year performance measurement period.
  - (4) Total includes 7,082 Restricted Stock Units, of which 3,111 are subject to future vesting, 1,953 Market Share Units, all of which are subject to future vesting, and 1,156 PSUs, all of which are vested.
