- (2) Operating Partnerships Units are redeemable for cash or shares of Common Stock at any time.
- (3) The right to convert Operating Partnership Units into shares of Common Stock has no expiration date.

- (4) Data Centers South Holdings LLC is the record holder of 6,346,835 Operating Partnership Units (the "Controlled OP Units"). Cincinnati Bell Inc. is the sole stockholder of Cincinnati Bell Technology Solutions Inc., which is the sole stockholder of Data Center Investments Inc., which is the sole stockholder of Data Centers South Inc., which is the sole member of Data Centers South Holdings LLC. As a result, Cincinnati Bell Inc. exercises investment discretion and control over the Controlled OP Units.
