This Schedule 13G/A is being jointly filed by Citadel Advisors LLC ("Citadel Advisors"), Citadel Holdings II LP ("CH-II"), Citadel Investment Group II, L.L.C. ("CIG-II") and Mr. Kenneth Griffin (collectively with Citadel Advisors, CH-II and CIG-II, the "Reporting Persons") with respect to shares of Common Stock of the above-named issuer (and/or options to purchase such shares) owned by Citadel Derivatives Trading Ltd., a Cayman Islands limited company ("CDT"), Citadel Securities LLC, a Delaware limited liability company ("Citadel Securities"), Surveyor Capital Ltd., a Cayman Islands limited company ("SC"), and PioneerPath Capital Ltd., a Cayman Islands limited company ("PPC").
