This estimate is made pursuant to Rule 457(c) solely for purposes of calculating the registration fee pursuant to (2)Rule 457(h), and is based on a price of \$16.62, which represents the average of the high and low prices per share of Common Stock as reported on the New York Stock Exchange on August 7, 2013.

## **INTRODUCTION**

By previous registration statements on Form S-8 (File Nos. 333-89302, 333-162893 and 333-183114) filed with the Securities and Exchange Commission (the “Commission”), Redwood Trust, Inc., a Maryland corporation (the “Company”), previously registered an aggregate of 300,000 shares of its common stock, par value \$0.01 per share (the “Common Stock”), reserved for issuance from time to time in connection with the 2002 Redwood Trust, Inc. Employee Stock Purchase Plan (as amended, the “Plan”). Under this registration statement, the Company is registering an additional 150,000 shares of Common Stock reserved for issuance from time to time in connection with the Plan.

Pursuant to General Instruction E of Form S-8, the contents of the above-referenced prior registration statements are incorporated into this registration statement by reference to the extent not modified or superseded hereby or by any subsequently filed document which is incorporated by reference herein or therein.
