Statement on Schedule 13D

This Amendment No. 1 supplements and amends the Schedule 13D that was originally filed on April 13, 2012 (the "Original Schedule 13D"), and is being filed to report the sale by certain of the Reporting Persons of shares of the common stock, par value \$0.00001 per share (the "Common Stock"), of Enphase Energy, Inc. (the "Company"), of an aggregate of 762,640 shares of the Common Stock. Only those items that are hereby reported are amended; all other items reported in the Original Schedule 13D remain unchanged. Information given in response to each item shall be deemed incorporated by reference in all other items, as applicable. Capitalized terms not defined in this Amendment No. 1 have the meanings ascribed to them in the Original Schedule 13D.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

Item 3 of the Original Schedule 13D is hereby amended to add the following statement:

On August 19, 2014, KPCB GGF sold 762,640 shares of Common Stock for a price of \$10.0269 per share of Common Stock or \$7,646,915.02 in the aggregate.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.
