In accordance with the designations of the Series A Junior Participating Preferred Stock, without any further action by the Issuer or the Filing Person, the 889.8162 shares of Series A Junior Participating Preferred Stock owned by the Filing Person were immediately after the stockholder vote converted into an aggregate of 9,084,104 shares of Common Stock of the Issuer.
