Jordan Wu beneficially owns 24,830,026 Shares and 3,280,730 Shares through Arch Finance Ltd. and Shu Chuan Investment Co., Ltd, respectively, both of which are investment companies controlled by Jordan Wu. Jordan Wu therefore may be deemed to have shared power to vote and dispose of 28,110,756 Shares. Accordingly, Jordan Wu may be deemed to beneficially own an aggregate of 28,181,114 Shares, representing approximately 8.3% of the outstanding Shares.

Arch Finance Ltd. directly owns and has shared power to vote and dispose of 24,830,026 Shares, representing approximately 7.3% of the outstanding Shares as of December 31, 2013.

Shu Chuan Investment Co., Ltd. directly owns and has shared power to vote and dispose of 3,280,730 Shares, representing approximately 1.0% of the outstanding Shares as of December 31, 2013.
