(976,500 common shares, 3,906,000 convertible bonds, and 43,750 warrants), UBS Eucalyptus Fund, LLC (713,000 common shares, 2,852,000 convertible bonds, and 43,750 warrants), PW Eucalyptus Fund, Ltd. (73,000 common shares, 292,000 convertible bonds, and 5,000 warrants). The ability of the Reporting Persons to convert the convertible bonds and warrants into common shares is subject to Blocker Provisions. Specifically, the convertible shares and warrants may only be converted to the extent that the conversion would not cause any of the Reporting Persons to be the beneficial owners of greater than 9.99% of the outstanding shares of the issuer's Common Stock.
