## Explanation of Responses:

- (1) The shares were sold in multiple transactions at prices ranging from \$71.72 to \$71.90. This amount represents the weighted average sale price of such transactions. The reporting person undertakes to provide full information regarding the number of shares sold at each separate price upon request by the Securities and Exchange Commission, the Issuer, or a security holder of the Issuer.
- (2) This amendment to Form 4 corrects the amount of securities beneficially owned by the Reporting Person following the transaction. Such amount was understated in the original filing by 1,934 shares due to a reporting error, which also resulted in the securities beneficially owned being understated by the same amount in Forms 4 dated 7/28/2013, 8/1/2013, and 8/7/2013.
- (3) The options vest in increments of one third annually on the first anniversary of the grant date of 7/28/2011.
- (4) This amendment to Form 4 reports the exercise of options inadvertently omitted from the original filing. Due to such omission, the amount of derivative securities beneficially owned by the Reporting Person was subsequently overstated by 1,934 shares on the Reporting Person's Form 4 dated 8/7/2013.
