- (1) On December 31, 2007, the GRAT exercised 25,000 stock options and, under the net settlement provisions of the applicable stock option agreement, 8,352 common shares were withheld in payment of the exercise price.
- (2) These shares were previously reported as being directly owned by the reporting person; such shares are indirectly owned by the GRAT.
- (3) The stock option became exercisable in three equal annual installments with the first installment being exercisable on January 1, 2002 and the second and third installments being exercisable on January 1, 2003 and January 1, 2004.

- (5) Such options were previously reported as being indirectly owned; the options were distributed from a grantor retained annuity trust and are owned directly by the reporting person.
