  - (1) Represents shares of the Issuer's common stock issued to the Reporting Person pursuant to the vesting of the restricted stock unit awards - performance based ("PSUs") that were awarded to the Reporting Person on February 19, 2016. The issuance was based on the level of achievement by the Issuer of certain pre-established performance metrics for the performance period January 1, 2016 to December 31, 2018 as certified by the Compensation Committee on February 12, 2019.
  - (2) Reflects 2 additional shares withheld to satisfy tax withholding obligations that arose upon prior vesting. On February 16, 2018, the reporting person filed a Form 4 reporting that 10,696 shares were withheld to satisfy tax withholding obligations.
