## Explanation of Responses:

- (1) These shares are being surrendered to SunPower Corporation, for no consideration, by Mr. Dinwoodie pursuant to an Equity Surrender Agreement signed on May 4, 2007. The Equity Surrender Agreement provides Mr. Dinwoodie with up to 10 ten days to surrender the shares to SunPower Corporation, which surrender will, in turn, allow SunPower Corporation to provide equity incentive compensation to certain PowerLight Corporation employees without dilution to SunPower Corporation stockholders. The shares will be surrendered on a pro rata basis from each of the four tranches with separate vesting dates, as further described in the equity restriction agreement described in footnote 2 below.
- (2) One half of these shares are subject to an equity restriction agreement with SunPower Corporation pursuant to which the shares are subject to certain transfer and repurchase restrictions. The restrictions lapse on one quarter of the shares semi-annually during the two-year restriction period, so long as Mr. Dinwoodie remains employed by SunPower.
