If a second higher-threshold financial target is met for fiscal (1) year 2007, then 3,333 of these shares will vest in 3 equal annual installments commencing March 31, 2008. If a certain approved individual goal is met for fiscal year 2007, then up to 1,667 of the shares will vest in 3 equal annual installments commencing March 31, 2008.
