 2000 Stock Incentive Plan: 14,366 restricted shares were awarded pursuant to H.B. Fuller Company's 2000 Stock Incentive Plan and vested on December 1, 2008. Total amount also includes restricted shares acquired pursuant to a dividend accrual feature of the 2000 Stock Incentive Plan.
- (2) Amended and Restated 2000 Stock Incentive Plan: 41,718 restricted shares were awarded pursuant to H.B. Fuller Company's Amended and Restated 2000 Stock Incentive Plan.
