("Knight"), Knight Holdco, Inc. (now KCG Holdings, (1) Inc.) ("KCG"), Knight Acquisition Corp, GETCO Acquisition, LLC and GA-GTCO Acquisition, LLC, these RSUs are immediately converted into RSUs of KCG, based on the exchange ratio of one third and on the same vesting terms as the current Knight RSUs (including accelerated vesting under certain circumstances).
