Also includes 8,493 RSUs voluntarily deferred by Mr. Stadler from his discretionary bonus, plus 2,123 RSUs granted to Mr. Stadler as a company match on his voluntary bonus deferral. These RSUs generally will be delivered on the third anniversary of grant. Also includes 9,706 RSUs that vest one-fifth ratably on each of January 27, 2007, 2008, 2009, 2010 and 2011. All of these RSUs were granted pursuant to the Company's 2004 Stock Incentive Plan.
