The record date for the distribution by Altria Group, Inc. (NYSE: MO) ("Altria") of all the shares of Kraft Foods, Inc. (NYSE: KFT)("Kraft") owned by Altria to holders of Altria common stock was March 16, 2007 at 5:00 p.m. Eastern Time. Altria currently holds (1) 275,000,000 shares of Kraft Class A common stock and 1,180,000,000 shares of Kraft Class B common stock. Prior to the Distribution, Altria will convert all of its 1,180,000,000 shares of Kraft Class B common stock into 1,180,000,000 shares of Kraft Class A common stock. The Distribution is scheduled to occur on March 30, 2007.
