Explanation of Responses:

- (1) On August 11, 2006, the reporting person was granted a restricted stock award of 100,000 shares subject to a four-year vesting schedule, vesting 15% each on 8/1/07 and 8/1/08, vesting an incremental 20% on 8/1/09 and vesting the remaining 50% on 8/1/10. This transaction reflects the tax withholding for the portion of the shares that vested on 8/1/10.
- (2) The options were assumed in connection with the company's acquisition of Shopping.com, Inc. on 8/30/05. The options are fully vested.
- (3) The option grant is subject to a two-year vesting schedule, vesting 25% on 3/1/07 and 1/24th per month thereafter.
- (4) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/09 and 1/48th per month thereafter.
- (5) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/10 and 1/48th per month thereafter.
- (6) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/08 and 1/48th per month thereafter.
- (7) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 01/16/09 and 1/48th per month thereafter.
- (8) The option grant is subject to a three-year vesting schedule, vesting 16.67% on 3/1/07 and 1/36th per month thereafter.
