This notification relates to issued common stock of the Company ("shares") and is given in fulfilment of the obligations imposed by sections 198 to 203 of the Companies Act 1985 (the "Act").

The Company was notified that as at close of business on 05 October 2004, The Goldman Sachs Group, Inc ("GS Inc") of 85 Broad Street, New York, NY 10004, USA, was interested, by attribution only, in a total of 30,476,971 shares.

Of these 30,476,971 shares:

The interest in 7,088,111 shares arose from Goldman, Sachs & Co. ("GS&Co."), a wholly-owned direct subsidiary of GS Inc, acting as custodian for its customers.

These shares are, or will be, registered in the name of Goldman Sachs Securities (Nominees), Limited.

The interest in 7,072,725 shares arose from GS&Co. acting as custodian for its customers of 94,303 American Depositary Receipts ("ADRs"). These ADRs are, or will be, held at the Depositary Trust Company of New York ("DTC").

The interest in 16,316,135 shares is a beneficial interest held by Goldman Sachs International, a wholly-owned indirect subsidiary of GS Inc. These shares are, or will be, registered at CREST in account CREPTMP.
