Unilever NV also announces that 123,534 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 57,319,015 Unilever NV ordinary shares in treasury, and has 1,657,408,685 Unilever NV ordinary shares in issue (excluding treasury shares).
