Unilever NV also announces that 7,737 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 98,944,489 Unilever NV ordinary shares in treasury, and has 1,615,783,211 Unilever NV ordinary shares in issue (excluding treasury shares).
