Explanation of Responses:

(1) Includes (i) 455 shares of Common Stock owned directly by Mr. Reimert and (ii) 356,020 shares of Common Stock subject to exercisable options. Excludes 12,000 shares of Common Stock owned by Mr. Reimert's wife, as to which Mr. Reimert disclaims beneficial ownership.

(2) Does not include 6,468,215 shares of Common Stock (including exercisable options to buy shares of Common Stock), with respect to Mr. Reimert, or 6,824,690 shares of Common Stock, with respect to Reimert Family Partners, Ltd., owned by certain stockholders of Dril-Quip, Inc. (the Issuer) who are parties to the Stockholders Agreement dated October 17, 1997 (the Stockholders Agreement). Pursuant to the Stockholders Agreement, certain stockholders of the Issuer have agreed to vote shares of common stock, par value \$.01 per share, of the Issuer held by each of them for the election of nominees to the Board of Directors proposed by each of (i) Larry E. Reimert and Reimert Family Partners, Ltd., (ii) Gary D. Smith and Four Smiths Company, Ltd. and (iii) J. Mike Walker. The parties to the Stockholders Agreement may be deemed to have formed a group pursuant to Rule 13d-5(b)(1) promulgated under the Securities Exchange Act of 1934, as amended (the Exchange Act). Any such group could be deemed to have beneficial ownership, for purposes of Section 13(d) and 13(g) of the Exchange Act, of all equity securities of the Issuer beneficially owned by such parties. Such parties would, as of the date hereof, be deemed to beneficially own an aggregate of 8,806,835 shares of Common Stock, or approximately 43% of the total number of shares outstanding, based on 19,271,973 shares outstanding as of December 31, 2005, plus the shares of Common Stock deemed outstanding pursuant to Rule 13d-3(1) under the Securities Exchange Act of 1934. Each of Mr. Reimert and Reimert Family Partners, Ltd. disclaims the beneficial ownership of any Common Stock owned by such other parties, except to the extent they may be deemed beneficial owners of such Common Stock for purposes of Section 13(d) and 13(g) as described above.

(3) Includes 1,982,145 shares of Common Stock owned directly by Reimert Family Partners, Ltd., as to which Mr. Reimert, as its managing general partner, exercises sole voting and dispositive power. Because Mr. Reimert exercises sole voting and dispositive power with respect to these shares, he may be deemed to be an indirect beneficial owner of these shares for purposes of Rule 13d-3.
