By letter dated October 3, 2006, the Company reported that on September 29, 2006 holders of Company s Convertible Notes that already had exercised their conversion right exercised their warrants rights. Hence, a reduction of 50,346 warrants and an increase of 99,144 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 220,703,693 to 220,802,837. The new amount of warrants outstanding is 25,713,774. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6093 for each share face value pesos 1. Therefore US\$ 60,409.25 entered into the Company.
