**Item 1.01. Entry into a Material Definitive Agreement**

On February 25, 2008, SYNnex Corporation, a Delaware corporation ( SYNnex ), announced that it had entered into a definitive agreement in which SYNnex will acquire substantially all of the assets of New Age Electronics, Inc. Total consideration for the purchased assets is approximately \$54.25 million, which includes approximately \$22.75 million in deferred and earn out payments that are subject to certain post-closing conditions, and approximately \$75.00 million of working capital debt assumption. Completion of the transaction is subject to regulatory and other approvals, and the satisfaction of other customary closing conditions. The full text of SYNnex 's press release is attached as Exhibit 99.1 to this report and incorporated by reference herein.
