The Annual Meeting of Stockholders of Pioneer Natural Resources Company (the "Company") will be held at 5205 North O Connor Boulevard, Irving, Texas 75039, Suite 250, on Thursday, May 17, 2012, at 9:00 a.m., Central Time. The Annual Meeting is being held for the following purposes:

1. To elect four Class III Directors, each for a term of three years.
2. To approve an amendment to the Company's Amended and Restated Certificate of Incorporation to provide for the annual election of directors.
3. To approve an amendment to the Company's Amended and Restated Employee Stock Purchase Plan to extend the term, increase the number of issuable shares and reduce the period of time for eligibility.
4. To ratify the selection of Ernst & Young LLP as the independent registered public accounting firm of the Company for 2012.
5. To hold an advisory vote to approve named executive officer compensation.
6. To consider a stockholder proposal relating to independent chairman.
7. To transact such other business as may properly come before the Annual Meeting.

**The Board of Directors unanimously recommends that stockholders vote FOR Items 1, 2, 3, 4 and 5; and AGAINST Item 6.**

The Board of Directors has fixed the close of business on March 22, 2012 as the record date for the determination of stockholders entitled to receive notice of and to vote at the Annual Meeting or any adjournment(s) thereof.
