**Item 2.01 Completion of Acquisition or Disposition of Assets.**

On May 30, 2012, a wholly-owned subsidiary of Terreno Realty Corporation (collectively referred to as the Company), completed the acquisition of an industrial property located in the Los Angeles Area consisting of five industrial buildings, aggregating approximately 545,000 square feet (the Property), from a third-party seller (the Seller), for a purchase price of approximately \$52.4 million. The Company utilized cash on hand and borrowings from its senior revolving line of credit to fund the acquisition.

There are no material relationships between the Seller and the Company or any of its affiliates, or any director or officer of the Company, or any associate of any such director or officer, other than in respect of the acquisition of the Property.
