Greenwich directly owns 9,830,100 Ordinary Shares. Greenwich is wholly owned by RRJ CM Fund I. RRJ Capital is the general partner of RRJ CM Fund I. RRJ Capital through its board of directors exercises investment discretion for RRJ CM Fund I. Therefore, each of RRJ Capital, RRJ CM Fund I and Greenwich is deemed to beneficially own 9,830,100 Ordinary Shares.

As the sole shareholder of RRJ Capital, Mr. Ong may be deemed to be the beneficial owner of the Ordinary Shares beneficially owned by RRJ Capital. Mr. Ong expressly disclaims beneficial ownership of the Ordinary Shares, except to the extent of his pecuniary interest therein, because the board of directors of RRJ Capital, which consists of six directors, exercises investment discretion for RRJ CM Fund I.

Hampton Asset Holding Ltd. ( **Hampton** ) directly owns 2,085,000 Ordinary Shares. Hampton is wholly owned by Mr. Ong.

None of RRJ Capital, RRJ CM Fund I or Greenwich directly or indirectly owns the Ordinary Shares directly owned by Hampton. Each of RRJ Capital, RRJ CM Fund I and Greenwich expressly disclaims beneficial ownership over the Ordinary Shares directly owned by Hampton.

All percentage calculations in this schedule are based on the 223,342,254 Ordinary Shares reported as outstanding by Cheniere as of December 17, 2012 in its definitive proxy statement filed with the Securities and Exchange Commission on December 31, 2012.
