On December 20, 2013, Kerry Peacock, a designee of The Toronto-Dominion Bank, resigned from the board of directors of TD Ameritrade Holding Corporation, effective immediately.

On December 27, 2013, Bharat Masrani, a designee of The Toronto-Dominion Bank, was elected to the board of directors of TD Ameritrade under the terms of TD Ameritrade's stockholders agreement, dated June 22, 2005, as amended. Mr. Masrani takes the place of Ms. Peacock. Mr. Masrani will enter into TD Ameritrade's standard form of indemnification agreement, a copy of which was filed as Exhibit 10.1 of Form 8-K filed by TD Ameritrade on June 5, 2006, and is incorporated herein by reference. He will not receive compensation for his service as a director.

On December 20, 2013, Todd M. Ricketts, a designee of the Ricketts parties under TD Ameritrade's stockholders agreement, resigned from the board of directors of TD Ameritrade in compliance with the terms of TD Ameritrade's stockholders agreement. His resignation is effective immediately prior to TD Ameritrade's annual stockholders meeting on February 12, 2014, also as provided in TD Ameritrade's stockholders agreement.
