ITEM 1.01 ENTRY INTO A MATERIAL AGREEMENT

On August 6, 2014, Kilroy Realty, L.P. (the Operating Partnership) issued and sold \$400,000,000 in aggregate principal amount of its 4.25% Senior Notes due 2029 (the Notes). The terms of the Notes are governed by an indenture, dated as of March 1, 2011 (the Base Indenture), by and among the Operating Partnership, as issuer, Kilroy Realty Corporation, as guarantor (the Company), and U.S. Bank National Association, as trustee, as amended and supplemented by a supplemental indenture, dated as of July 5, 2011 (the Supplemental Indenture), by and among the Operating Partnership, as issuer, the Company, as guarantor, and U.S. Bank National Association, as trustee.

The foregoing descriptions of the Notes, Base Indenture and Supplemental Indenture do not purport to be complete and are qualified in their entirety by the full text of the Base Indenture, Supplemental Indenture and the Officers Certificate establishing the terms of the Notes, which are being filed herewith or incorporated by reference herein, as the case may be, as Exhibit 4.1, Exhibit 4.2 and Exhibit 4.3, respectively, to this Current Report on Form 8-K.
