### **Explanatory Note**

The purpose of this Amendment No. 2 (the Amendment No. 2 ) to the Schedule 13D filed with the U.S. Securities and Exchange Commission on November 17, 2017, as amended on May 25, 2018 (the Schedule 13D) is to reflect an increase in the percentage of the shares of Common Stock, par value \$0.01 per share (the Shares), of Greenhill & Co., Inc., a Delaware corporation (the Issuer), beneficially owned by the Reporting Persons resulting from a decrease in the outstanding Shares. Except as set forth below, all Items of the Schedule 13D remain unchanged. Capitalized terms used in this Amendment No. 2 and not otherwise defined shall have the respective meanings assigned to such terms in the Schedule 13D.

#### Item 5. Interest in Securities of the Issuer.

Item 5 is amended and restated as follows:

(a) See Item 9 on the Cover Pages to this Amendment No. 2. Percentages are based on 21,303,842 Shares outstanding as of August 29, 2018.

As of the date hereof, the Reporting Persons beneficially own 2,091,493 Shares as a group, representing approximately 9.8% of the outstanding Shares.

<u>Robert F. Greenhill.</u> Robert F. Greenhill is the direct beneficial owner of 282,579 Shares, representing approximately 1.3% of the outstanding Shares.

<u>Greenhill Family Limited Partnership.</u> Robert F. Greenhill controls Greenhill Family Limited Partnership. Greenhill Family Limited Partnership is the direct beneficial owner of 989,524 Shares, representing approximately 4.6% of the outstanding Shares.

<u>Riversville Aircraft Corporation II.</u> Robert F. Greenhill controls Riversville Aircraft Corporation II. Riversville Aircraft Corporation II is the direct beneficial owner of 239,680 Shares, representing approximately 1.1% of the outstanding Shares.

<u>Socatean Partners.</u> Robert F. Greenhill controls Socatean Partners. Socatean Partners is the direct beneficial owner of 579,710 Shares, representing approximately 2.7% of the outstanding Shares.
