(1) Each share of class B common stock, par value \$0.01, of the issuer (the "Class B Common Stock") is convertible at any time, at the option of the holder, into one share of class A common stock, par value \$0.01, of the issuer (the "Class A Common Stock").

(2) No expiration.

(3) On June 17, 2005, and August 1, 2006, the reporting person was granted an aggregate of 1,440,000 shares of restricted Class B Common Stock. The restricted Class B Common Stock vests upon certain liquidity events if certain performance criteria are met. Upon the occurrence of the Issuer's recent secondary public offering, which was consummated on May 25, 2007, 373,621 shares of restricted Class B Common Stock vested.

(4) Includes 29,373 shares of Class B Common Stock, which will vest on February 22, 2008, if the recipient of such shares continues to be employed by the issuer or any of its subsidiaries at that time.
