- These shares are owned directly and solely by Caisse de d?p?t et placement du Qu?bec. Eric Lachance, investment manager of Caisse de d?p?t et placement du Qu?bec and Dave Brochet vice president of Caisse de d?p?t et placement du Qu?bec, have shared investment and voting power with respect to, and therefore may be deemed the beneficial owners of, the securities owned by Caisse de d?p?t et placement du Qu?bec. Each of Messrs. Lachance and Brochet disclaim beneficial ownership of the securities of the Issuer owned by Caisse de d?p?t et placement du Qu?bec except to the extent of their pecuniary interest therein, and this report shall not be deemed an admission that either Mr. Lachance or Mr. Brochet is the beneficial owner of the securities for purposes of Section 16 or for any other purpose.
- The series C participating convertible preferred stock is convertible into common stock at any time at the holder's election on approximately a 1 to 14.84 basis, and has no expiration date. The Issuer has exercised its right to require the conversion of these shares.
- (3) Therefore, each outstanding share of series C participating convertible preferred stock will convert into approximately 14.84 shares of common stock upon the consummation of the Issuer's initial public offering.
